Helping Nordic education providers navigate privacy assessments - the case of Denmark

Session description

Google Workspace for Education has come into the center of a discussion in Denmark with regulators and educators when the Danish Datatilsynet in July issued a temporary ban on the use of these products at the schools of Helsingør municipality. The decision brought into the spotlight the complexities and challenges of conducting effective data privacy impact assessments (DPIAs) by the municipalities on their use of third-party technologies. At this breakfast workshop, Google Cloud Privacy and Compliance experts/leadership will discuss recent lessons learnt from Denmark, and run you through tips and guidance on how to carry out a DPIA on Google Workspace products.
